# MEMORIAL "F. CALISE" Meeting International of Handball

## **GAME RULES**

## A – Observe application of the F.I.G.H./I.H.F. Rules

## **B-SCORE**

The rule adopted for the score in the eliminatory phase is this:

3 points in the case of victory - 1 point in the case of a draw - 0 points in the case of defeat.

In the semi-final and final stage, in the case of a draw at the end of the match, there will be extra time of 5 minutes.

In the case of there being draws, penalties will be played by 5 different players, alternating shots. In the case of further draws again penalties will continue alternating shots until one of the two teams is in advantage.

## **C-TIME OF GAMES**

Category UNDER 21 – UNDER 18 – UNDER 16 - UNDER 14 - UNDER 12

Eliminatory phase and semi-final: 2 half-times of 15 minutes with an interval of 5 minutes. 1 minute for a player sent off. 1 minute for time out

Final stage: 2 half-times of 20 minutes with an interval of 5 minutes. 1 minute for a player sent off. 1 minute for time off.

Category A: 2 half-times of 25 minutes with an interval of 5 minutes. 1 minute for a player sent off. 1 minute for time out.

## **D-PLAYER RECOGNITION**

The player will be recognised by the presentation of a valid identity document, which will be done on the field by the referee or together with the field delegate, only the first time that the team enters the field. The list of the recognized players will be that valid for the whole tournament and no different player from those already recognized will be admitted. The Request of recognition of the players by any other team must be presented to the referee in advance before the match starts. The list of the 12 players who will be participating in the match must be presented 15 minutes before the game.

## E – LATE ARRIVAL, RENOUNCE, WITHDRAWAL

The team, which arrives on the field 5 minutes late, without justifiable motivation, or which does not present itself at all or even withdraws from a game already in progress, loses the match with a 0-6 score and will be penalised by losing 6 points in the classification.

## F -COMPLAINTS

A complaint must be presented by the Team Manager for scrutiny by the Field Delegate of the Organisation in the Secretary's office within one hour after the end of the game.

#### G - REFEREE

The referee will be designated by a responsible referee or by a substitute in case of absence. The nominee will be communicated by 08.15 on the day of the match. There will be designated from 3 to 4 referees to each field who alternate between themselves for each match; one of the referees who is not engaged in arbitration, will be available for recognition of the players before the following match in which he will be arbitrating.

The referees will be responsible for scoring and time-keeping.

#### **H-REPORTS**

All the reports must be delivered to the Technical Secretary or the Field Delegate of the Organisation at the end of the game. I-VARIOUS

The players of each team must present themselves 10 minutes before the beginning of each game at the field where they will be playing with a passport or ID.
